UK Tidal API - Premium

This module, in combination with the Terms of Use for API Access, set out the terms on which the United Kingdom Hydrographic Office (the “**UKHO**”, “**we**”, “**our**” or “**us**”) makes data (the “**Data**”) available (on a subscription basis) to you, the entity or person entering into these Terms as a developer (“**you**” or “**your**”), through an Application Programming Interface (the “**API**”) for the purposes of developing web or mobile applications, for use by end users authorised by you (the “**End Users**”), on any platform, such that End Users are able to access the Data (the “**Solution**”).

Your access to, and use of, the Data through the API is subject to the Terms (as that term is defined in the Terms of Use for API Access) and all applicable laws and regulations.

Subscription Period	Twelve months
Third Party Restrictions	There are no Third Party Restrictions on data made available through the API
UKHO's Cap on Liability	The UK Hydrographic Office's liability to limited to equivalent/equal to annual subscription amount of the API

Fair Use Limits Package	<p>For the avoidance of any doubt, any reference to a Data request in this Module shall relate to one single use of that Data. You and your End Users shall only use Data obtained from each Data request once.</p> <p>Your Solution shall, for the Subscription Period:</p> <ul style="list-style-type: none"> (a) make no more than 100,000 Data requests per month (maximum throughput); or (b) make no more than 100 Data requests per second (maximum volume). <p>Exceeding these Fair Use limits will result in:</p> <ul style="list-style-type: none"> (c) a 403 'Quota Exceeded' Error message for breaching 100,000 Data requests per month per subscription (d) a 429 'Too Many Request' Error message for breaching 100 Data requests per second per subscription. <p>If you reach the limits in a Fair Usage Package and you wish to purchase additional data usage, you will have to purchase an additional Fair Usage Limits Package in accordance with clause 3 of the Terms of Use for API Access [insert link].</p>
Caching Limits	<p>The following time limits apply:</p> <ul style="list-style-type: none"> (e) The Data can be cached for a period of no longer than 168 hours. (f) The Data stored should not be made available after 168 hours
